# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to www.integralityllc.com, and Integrality, LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Integrality, LLC include www.integralityllc.com, Integrality, Start.Pivot.Grow. and www.startpivotgrow.com. The Integrality website is a learning management system and ecommerce platform site. By using the Integrality website, you consent to the data practices described in this statement.

# **Collection of your Personal Information**

In order to better provide you with products and services offered, Integrality may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number
- Job Title
- Tax Identification Number

If you purchase Integrality's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

Integrality may also collect anonymous demographic information, which is not unique to you, such as your:

- Gender
- Race
- Business Income

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

Integrality collects and uses your personal information to operate and deliver the services you have requested.

Integrality may also use your personally identifiable information to inform you of other products or services available from Integrality and its affiliates.

# **Sharing Information with Third Parties**

Integrality does not sell, rent or lease its customer lists to third parties.

Integrality may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third party. - Comply with the California Electronic Communications Privacy Act;
- Engage in public or peer-reviewed scientific, historical, or statistical research in the public interest that adheres to all other applicable ethics and privacy laws, when our deletion of the information is likely to render impossible or seriously impair the achievement of such research, provided we have obtained your informed consent;
- Enable solely internal uses that are reasonably aligned with your expectations based on your relationship with us;
- Comply with an existing legal obligation; or
